1. The Ngamba Island Chimpanzee Sanctuary has received funds from Government of Uganda to be used for the refurbishment of electric fence line at Ngamba Island Chimpanzee Sanctuary.
2. The Entity invites sealed bids from eligible bidders for the provision of the above works.
3. Bidding will be conducted in accordance with the open bidding method and is open to all bidders.
4. Interested eligible bidders may obtain further information and inspect the bidding documents at the address given below in No. 8(a) from 8.30am to 5.30pm.
5. The Bidding documents in **English** may be purchased by interested bidders on the submission of a written application to the address below at 8(b) and upon payment of a non-refundable fee of **UGX 50,000 (Uganda shillings fifty thousand only)**. The method of payment will be cash.
6. Bids must be delivered to the address below at 8(c) at or before **3.00pm on 19<sup>th</sup> May 2017**. All bids must be accompanied by a bid securing declaration. Bid securing declarations must be valid until **27<sup>th</sup> June 2017**. Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 8(d) at **3.15pm on 19<sup>th</sup> May 2017**
